Dear members!

Dear friends of the marimba!

Marimba Festiva Association focuses on fostering the younger marimba generation. Starting eight years ago, we have been supporting young musicians and offering a platform for their committed development as artists. Various small and large events have enhanced the possibilities for international interchange and led to stronger bonds between marimbists from different places all around the world. The basic idea has been understood and accepted. The list of members is long, diverse as well as international and full of important artists – professors and tutors, fans of the marimba, freelance musicians and students.

The lockdown has quickly proven that the arts are a sensitive branch for which it is particularly hard to get the necessary support. Especially freelance artists and students are highly dependent on financial initiatives to compensate for cancelled concerts and events.

In the last few weeks, we have heard a lot about **solidarity**, which has become an essential part of all facets of life. Many support programmes have been initiated to help people through the struggles caused by the corona virus. In these difficult times, society is moving closer together, which we consider to be an enrichment regarding charitable aspects.

One of our ideas of contribution is to use grants in order to organize smaller concerts in public places to both re-activate cultural life and present the marimba. Marimba Festiva Association would give small fees to the artists and offer further organisational support.

As members of the board, we would like to start a fund for supporting our members.

We especially would like to appeal to those who are lucky enough to have an assured income and would be able to spare at least a small amount of money.

Furthermore, we want to direct our petition to the International Society to find more supporters.
